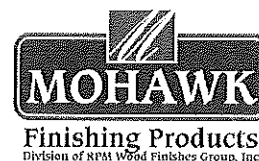

### 4. First-aid Measures

### 5. Fire-fighting Measures

## 7. Handling and Storage
